

100% Main Event Bonus

Land Prime Ltd (hereinafter referred to as "the Company") offers a 100% Main Event Bonus (hereinafter referred to as "the Bonus") to customers who meet the Company's conditions, which will be reflected in the customers' trading accounts.

Terms and Conditions

- 1. You agree to and acknowledge these terms and conditions by opening a bonus account.
- 2. The application period for the bonus account is from July 20, 2024, to August 11, 2024, and the Company reserves the right to change or terminate it without user consent.
- 3. The bonus account offers two types of bonuses: Daily bonuses during the Main Events and post-Main Events bonuses.
- 4. The amount of the daily bonus is determined based on the number of coins won by the Japanese team the previous day:
 - Gold coin per unit: ¥20,000
 - Silver coin per unit: ¥10,000
 - Bronze coin per unit: ¥5,000
- 5. The daily coin count is based on the Paris time zone.

For example, the bonus amount on August 1 is determined by the number of coins won by 23:59 Paris time on July 31.

The daily bonus amount displayed on the website is updated at 13:00 Japan time.

- 6. The daily bonus is 100% of the deposit amount for deposits of ¥10,000 or more on the day, up to the amount corresponding to the number of coins won (see detailed conditions below).
 - a. If making daily deposits:
 - The Available bonus amount on My Page is updated daily at 13:00 Japanese time.
 - Deposit ¥10,000 or more based on the bonus amount for the day.
 - The bonus is credited simultaneously with the deposit.
 - The daily bonus applies to deposits completed daily by 13:00 Japan time (4:00 server time).
 - Multiple partial deposits totalling ¥10,000 or more are also eligible for the bonus.
 - b. If making a lump-sum deposit:
 - Deposit ¥10,000 or more.
 - The Available bonus amount on My Page is updated daily at 13:00 Japan time.
 - The bonus is automatically credited up to the deposit amount based on the daily bonus amount.
 - Multiple partial deposits totalling ¥10,000 or more are also eligible for the bonus.
 - c. Fund transfers are not eligible for the bonus.



d. The deposit methods are limited to Bank transfer, Bitwallet, and STICPAY.

e. The bonus is reflected as credit and can be used as a margin for trading but cannot be withdrawn.

- f. The bonus applies to only one account per person.
- g. The bonus will be invalid if no transactions occur within three days.
- h. The bonus will only be reflected once KYC verification is completed.
- 7. The post-Main Events bonus amount is determined based on the final performance of the Japanese team:
 - 1st place: ¥1,000,000
 - 2nd place: ¥800,000
 - 3rd place: ¥600,000
 - 4th place: ¥400,000
 - 5th place: ¥200,000
 - 6th place: ¥100,000
 - 7th to 10th place: ¥50,000
 - Below 10th place: No bonus
- 8. The post-Main Events bonus applies to deposits made within one week after the Main Events (by 23:59 Japan time on August 18, 2024).
 - a. Multiple partial deposits totalling ¥10,000 or more are also eligible for the bonus.
 - b. Fund transfers are not eligible for the bonus.
 - c. The deposit methods are limited to Bank transfer, Bitwallet, and Sticpay
 - d. The bonus is reflected as credit and can be used as a margin for trading but cannot be withdrawn.
 - e. The bonus will be invalid if no transactions occur within 30 days.
- 9. The Company is not responsible for missed bonus opportunities due to overlooked email newsletters or social media announcements.
- 10. The maximum leverage for the bonus account is 500:1.
- 11. The margin call and stop-out levels for the bonus account are as follows:
 - A. Margin call level: 100%
 - B. Stop-out level (loss cut): 60%
- 12. Transfer or sale of accounts to third parties is prohibited.
- 13. If you cannot prove the source of funds, fail to comply with verification, or it is determined that the funds are not yours, the Company has the authority to cancel profits from trades, deduct bonuses, and suspend or stop usage (including bank transfers and e-wallets).
- 14. The bonus cannot be applied to other accounts.
- 15. If any funds are withdrawn or internally transferred from the account, the entire bonus amount credited to the trading account becomes invalid.
- 16. The Company reserves the right to stop bonuses in cases of:



- Use of third-party accounts
- Transfer or sale of accounts to third parties
- Opening multiple accounts or trading from the same IP address
- Arbitrage
- Bonus abuse (including but not limited to profiting through trading with the provided bonus and securing profits via withdrawals or internal transfers when profits are made, and covering losses with the bonus when losses occur)
- Hedge trading between multiple companies or suspicious transactions
- Hedge trading between multiple accounts within the Company or suspicious transactions
- Hedge trading within specific groups or suspicious transactions
- Transactions deemed malicious by exploiting defects in the Company's services or systems
- Transactions utilising connection delays or rate errors
- Extremely high-speed trading that imposes a load on the server
- Fraudulent cashback arbitrage linked to bonuses
- Transactions to receive bonuses
- Transactions to accumulate bonuses
- 17. The Company reserves the right to modify or terminate the bonus at any time if these terms are violated.
- 18. In the event of intentional or unintentional prohibited activities, the Company reserves the right to take the following actions without prior notice:
 - Refusal, suspension, or refund of deposits/withdrawals from the relevant or related accounts
 - Suspension or freezing of relevant or related accounts
 - Nullification of profits generated in relevant or related accounts
 - Termination of services and contracts provided by the Company
 - Freezing or closing of relevant accounts
 - Nullification of profits and IB commissions
- 19. The Company will determine the presence of prohibited activities, and the user will not require an explanation or proof of the basis.
- 20. The final decision regarding the bonus lies with the Company.
- 21. The Company reserves the right to terminate the bonus any time.
- 22. The Company reserves the right to change these terms without prior notice.
- 23. These terms and conditions are effective from July 20, 2024.
